Core Competence Course for Working with CYP

All placement Counsellors working with CASY must attend this workshop within 6 months of starting placement.

The training is in three parts all designed to build of your understanding of human development, gain confidence in unique ethical and legal challenges CYP counsellors face and gain tangible tools that you can take directly into the counselling room.

The Webinars

• Part 1 – Understanding Development

Introduction to Dynamic Maturation Model of Attachment, psychosocial development, teenage brains & pressures on young adults.

• Part 2 – Law and Ethics around working therapeutically with CYP

Role of ethics in counselling CYP, Ethical decision making and UK Law relating to; capacity & consent, confidentiality, and safeguarding.

• Part 3 – Skills and adaptations for therapeutically work with CYP

Focusing on adapting skills and practices for working with under 11's, early teens and young people.

Self-Led Study

To supplement your learning and receive your certificate in CYP competence you will need to complete CPD in the following areas.

This ensures that we cover all the competencies relating to working therapeutically with CYP. 7 These CPD hours can be found many formats from book chapters, blogs, podcasts, lectures at university, documentaries, and other relevant media.

Case Study

The final part of this course is to write a short case study (500-1000 words) that demonstrates understanding of one or more of the topics covered in the training. Cost for whole course: £300 if you are qualified counsellor or £200 if you are a trainee not affiliated with CASY.

CORE Webinars

Our training is designed to support your growth and development as a counsellor. The CORE webinars we cover are:

- **Safeguarding:** Understanding and working within the limits of CASY's safeguarding policy. This unit is compulsory to both Qualified and Trainee Counsellors.
- **Beginnings and Endings:** Equipping counsellors to gain a better understanding of beginning and ending's within short term work. This unit is optional for Qualified counsellors and Compulsory for trainee counsellors.
- **Pre-trial Therapy:** Gaining a better understanding of the CPS guidance surrounding pretrial therapy. This unit is compulsory to both Qualified and Trainee Counsellors.

- **Suicide:** Equipping practitioners to respond with sensitivity, confidence, and care. While we strongly encourage all counsellors to attend the webinar, this unit is optional for Qualified Counsellors, and Compulsory for Trainee Counsellors.



Our 'Suicide' training is Quality Checked by the National Counselling and Psychotherapy Society (NCPS). This course alone is not a route to the Accredited Register nor does it fully equip a graduate to practice as a qualified counsellor.

- **Self-harm:** Supports counsellors in developing a compassionate and informed approach to working with self-harm. While we strongly encourage all counsellors to attend the webinar, this unit is optional for Qualified Counsellors, and Compulsory for Trainee Counsellors.



Our 'Self-Harm' training is Quality Checked by the National Counselling and Psychotherapy Society (NCPS). This course alone is not a route to the Accredited Register nor does it fully equip a graduate to practice as a qualified counsellor.

What do CASY webinars involve?
